NAME OF THE SOCIETY 1.

The name of the Society shall be Partners in Prosperity (herein after referred as PnP).

AIMS AND OBJECTS 3.

Preamble

The present era has been witnessing the emergence of fast and complex process of changes in the human development process. The process of making public policy making are responding to multi-faceted problems may it be in peace and security, advancement in scientific knowledge, environmental improvement, social and cultural harmony, ethnic diversity and economic progress. PnP will be established in India to promote better public awareness, policy dialogues and debates, action programmes on the vital issues related to human welfare, particularly in Asia and Africa.

The aims and objects for which the society is established are as under:

- To act as a clearing house for economic, scientific and technical cooperation on e) subject contributing to sustainable development;

To inform, educate and make people become aware of the values of mutual cooperation;

To create a mechanism for advocacy, legal aid and information services on common causes and issues affecting human future;

- h) To conduct and promote conceptual and policy relevant review research; investigate, document, print, publish, network, store and disseminate information on issues relevant to the concerns of those engaged in sustainable development;
- To undertake, facilitate, organise or cause to organise training course, conferences, seminars, workshops, lectures and other educational opportunities for those involved in, and concerned with human welfare;
- To study, analyze, and disseminate policies, programmes and legislations affecting cooperation in the Asian and African region and organizations interested in the region;
- k) To work towards developing and fostering mutual cooperation, understanding and common action among various individuals, groups and organizations engaged in sustainable development and to establish cooperation and linkages with other networks, forums and Societies.
- 4. For the above purposes or in furtherance thereof:
 - To publish reviews, books, brochures, monographs, newsletters, bulletins, journals and pamphlets.
 - ii) To hold as owners, projects, training centres and related under takings.
 - iii) To engage and to remove specialists, experts, technicians, manager, secretaries, accountants, clerks, servants and workmen, and others and to pay them salaries, wages, gratuities, pensions and honoraria.
 - iv) To the same extent as natural persons might or could do to acquire, by purchase lease, mortgage, loan, gift, grant, legacy, bequest, exchange, rights, privilege, or otherwise from any person, company, society, government, institution or body whatsoever and to hold all or any part of the movable and immovable property of all descriptions
 - v) To borrow and to raise funds with or without security, in any manner the Society may think fit and to repay the same.
 - vi) To invest, lay aside, deposit in banks, or otherwise, deal with the moneys or funds of the Society not immediately required for the objects of the Society and to subscribe for purchase, acquire, hold, sell, endorse and negotiate in every way debentures, stocks, shares and securities of every description.
 - vii) To negotiate with and to enter into any manner of arrangements with any Government or authority whether Supreme, State, District, Municipal, University, Local or otherwise or any public or private body, whether within or

outside India, as may seem conducive to the promotion or accomplishment of the objects of the Society or any of them and to apply for, obtain, collect, receive or recover from any such Government or authority or body such grants, allowances, rights, concessions or privileges as may seem from time to time, desirable and to obtain, carry out, exercise, comply with and utilize the same.

- To alienate by way of sale, mortgage, lease, release, loan charge, hypothecation, pledge, exchange, hiring out, gift, or otherwise, with or without security, any or all the portion or portions thereof including the making or giving of subscription, contribution or assistance pecuniary or otherwise to other institutions, bodies, or person or otherwise to benevolent, institutions, bodies, or person as from time to time may seem necessary or appropriate.
 - All the incomes, earnings, moveable and immovable properties of the society ix) shall be solely utilized and applied towards the promotion of its aims and objects only as set forth in the Memorandum of Association and no profit on thereof, shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever to the present or past Members of the society or to any person claiming through any one or more of the present or the past members. No member of the society shall have any personal claim on any moveable or immovable properties of the society or make any profits, whatsoever by virtue of this membership.
 - To do or to cause to be done or all such acts, or things, as shall be conducive to X) the social, moral, material, civil, physical and other welfare of human beings; provided such acts or things shall not be contrary to nor inconsistent with the spirit of the laws under which this Society has been organized and registered.
